## City of Rock Falls Off-Highway Vehicle Application

Pursuant to Rock Falls municipal code, certain non-highway vehicles may be approved for use on specified streets, roadways, and alleys in the City of Rock Falls where the posted speed limit is 35 miles per hour or less. Non-highway vehicles may not be used on any toll road, interstate highway, controlled access highway, or other highway or roadway under jurisdiction of the State of Illinois. At present, "non-highway vehicles" include those vehicles defined under the law as "recreational off-highway vehicles". "Recreational off-highway vehicles" mean any motorized off-highway device designed to travel primarily off-highway, 64 inches or less in width, having a manufacturers dry weight of 2,000 pounds or less for a gas engine, or 3,000 pounds or less for electric-powered engines, travelling on 4 or more non-highway tires, designed with a non-straddle seat and a steering wheel for steering control, excluding equipment such as lawnmowers. Applicants shall be required to comply, in all respects, with the applicable Rock Falls municipal code and the Illinois Vehicle Code, including the obligation to obtain an annual permit. Violations may result in suspension or revocation of the permit and/or significant fines or other penalties.
