

#### Year-End Report 2023

I present to you the Police Department's Year-End Report for calendar year 2023. This report will provide an overview of the activities of the Police Department throughout the year. The Rock Falls Police Department is committed to providing a safe environment for the citizens and visitors to the City of Rock Falls and will continue to develop strategies to combat criminal activity and public safety concerns throughout the city.

The Police Department saw 16.5% increase in total calls for service over 2022. Officers were called to respond to 13,226 calls. Staffing at the Department remained steady throughout the year at one below the authorized staffing level. One officer was hired in December, however an officer resigned around the same time. The Police Department will be hiring in 2024 and have begun planning for future recruiting to ensure an ongoing dialogue with those interested in the career and to attract new recruits to the Department as needs change over time.

In September, the "no cash bail" sections of the "Safe-T Act" were implemented after being delayed by court challenges. After spending much time on training for this in 2022, officers underwent refresher training prior to the September 18<sup>th</sup> beginning date. As expected, there have been many issues with this law that have required constant adjustment and rethinking from an operational standpoint. It is my hope that the General Assembly will take the time to meet with law enforcement, victim's advocates, and other stakeholders to correct some of the flaws with the legislation.

In 2021, NIBRS (National Incident Based Reporting System) became the national standard for law enforcement crime data reporting in the United States. The transition to NIBRS represents a significant shift – and improvement – in how reported crime is measured and estimated by the federal government.

NIBRS captures detailed data about the characteristics of criminal incidents, including:

- a broad array of offenses;
- types and amount of property lost;
- demographic information about victims, offenders, and persons arrested;
- what type of weapon, if any, was used in the incident.

NIBRS data more accurately reflects the types of crime addressed by police agencies, like simple assault, animal cruelty, destruction of property, intimidation, and identity theft. The broad scope of the information collected in NIBRS will greatly improve the nation's understanding of crime and public safety.

Beginning in 2022, the Rock Falls Police Department began contributing data to the Bureau of Justice National Incident Based Reporting System (NIBRS). Data sets were submitted for the entirety of 2023 and the Department is considered fully NIBRS compliant. This report will include some of the NIBRS statistics reported for Rock Falls in 2023.

The Police Department was finally able to deploy the long-delayed electronic ticketing system in late 2023. This system allows officers to complete citations and warning electronically, in the field. It streamlines the process and increases the quality of the citations. A vast improvement over the traditional multipart, carbonless duplicates. There have been some kinks that we continue to work out but officers, police department staff, and the courts have adjusted well.

The Whiteside County Sheriff's Department, who operates the consolidated dispatch center that serves Rock Falls Police, announced they would be consolidating the operations of the Sterling dispatch center with the Morrison center in 2024. Along with this change they announced they would be replacing the computer-aided dispatch software (CAD) which Rock Falls Police rely on for records keeping and incident documentation. The software package includes a Records Management System (RMS) which will allow better integration between the CAD and RMS systems than we are able to achieve currently.

In 2023, the Police Department administration began a program to emphasize officer accountability and activity which has resulted in a significant increase in officer-initiated patrols and enforcement. This push accounts for a portion of the increased calls for service. One of the most significant increases as a result of this initiative is a doubling of the number of officer-initiated building and business checks performed in 2023. Having officers visible and proactively patrolling reduces crime opportunities, increases public perception of the Department, and leads to a better overall community.

Rock Falls Police Officers continued to be active in the community through many different programs. Officers worked at many of the Downtown Riverfront events, parades, and other details throughout the city. In December the Police Department held their annual Operation Santa Claus Christmas program, raising nearly \$7000 and helping 6 families in Rock Falls with a total of 21 children to provide Christmas gifts and a meal as well as other household needs. It is a welcomed reminder of our connection to serving the community.

In closing, I look forward to a successful and productive 2024 and look forward to continuing the growth and improvements from the previous years.



#### **TRAINING**

Officer training is a priority. The Rock Falls Police Department devotes substantial time and resources to ensure all the officers receive more than the minimum required training. State mandated training constitutes a substantial portion of the years training, and all officers are compliant with Illinois mandated trainings.

Throughout the year, officers attended training on many topics and areas. Where possible, Rock Falls Police utilize in-house trainers or local training opportunities. Taking advantage of local talent helps to stretch the training budget.

Every month officers are required to train with the issued weapon(s) as well as being required to maintain up to the date information on state laws and case law that affects them. Officers also participate in force-on-force active threat training annually.

Officers who are part of the Twin City Special Response Team train guarterly with the team.

In 2023, Rock Falls Police Officers spent well over 1200 hours in training over the course of the year.

Training will continue to be a priority as the responsibilities placed on officers increase and the mandated training list grows.

Additionally, officers in leadership positions and those who aspire to leadership roles will be attending training to develop those skills to place them in a position to succeed as the next generation of RFPD leaders.

All officers are compliant with State of Illinois Law Enforcement Training and Standards Board required training.

The Northwestern School of Police Staff & Command (SPSC) is an intensive leadership and management education program that helps prepare experienced law enforcement professionals for success in senior command positions.

Since its inception in 1983, law enforcement agencies throughout the U.S. and around the globe have recognized the important impact a SPSC education makes on their leadership and management teams. Through an innovative combination of academic principles with practical applications, the 10-week SPSC curriculum zeroes in on such critical command-level content as planning and policies, media relations, organizational behavior, budgeting and resource allocation, human resources, contemporary policing, and more.

#### K-9 UNIT YEARLY REPORT - 2023

The Rock Falls Police Department K9 Unit, consisting of Patrol Officer Dustin Sugars and K-9 Fahgo were deployed 108 times throughout the year.

The K-9 Unit completed 96 Free-Air Sniffs of vehicles and/or articles and conducted 12 tracks and/or article searches.

As a result of these deployments the following items were seized:

25.4 grams of Methamphetamine 683.889 grams of Cannabis 20.5 grams of Cocaine 1 gram of Heroin 0.5 grams of Crack 12 Benzo/Xanax Pills 7 items of Drug paraphernalia



24 criminal arrests were made with the assistance of K9 Fahgo

The K9 Unit conducted several community policing events throughout the year including demonstrations at the Whiteside Area Career Center, Dillon School, and the Whiteside County Health Department's Touch-a-Truck.

Fahgo also made countless appearances at community events at the RB&W Park and several businesses in the area.

The K-9 Unit was utilized by not only Rock Falls Police, but also the Sterling Police Department, the Whiteside County Sheriff's Office, the Illinois State Police and the Blackhawk Area Task Force.

Officer Sugars and K9 Fahgo completed 182 hours of training for the year.

The K9 Unit is a great asset not only for criminal detecting and narcotics investigation, but also for Community Relations.







# **NATIONAL INCIDENT BASED REPORTING SYSTEM (NIBRS)**

Implemented to improve the overall quality of crime data collected by law enforcement, NIBRS captures details on each single crime incident—as well as on separate offenses within the same incident—including information on victims, known offenders, relationships between victims and offenders, arrestees, and property involved in crimes. The Rock Falls Police Department is 100% NIBRS compliant in our reporting and data collection. This is a relatively new program, and we are working on how best to interpret and utilize the data generated.

#### Overview:

2023 had a disturbing increase in sexual assault, child abuse, and child pornography cases from 2022.

Ten cases in 2023 resulted in firearms being recovered or seized. Some of said cases involved multiple firearms, so the number of cases does not reflect the actual number of firearms processed by the Detective Section. Besides the physical processing of the firearm, the Detective Section is also tasked with entering the weapons into LEADS and running each firearm through the Bureau of Alcohol, Tobacco, Firearms and Explosives. Firearms recovered by the Rock Falls Police Department must go through a timely court ordered process before they can be destroyed.

The Detective Section investigated the total of seven deaths in 2023.

5 were drug overdose deaths (required a detective to attend autopsy) 2 were suicide by firearm (required a detective to attend autopsy)

The Detective Section also investigated a case that was reported as an aggravated battery with a firearm. A thorough investigation proved it was an attempted suicide.

The Detective Section has been able to increase communication with the residents of Rock Falls in 2023. This was able to be accomplished by offering more educational seminars.

ALICE (active shooter training) was presented and taught to the staff/administration for several of the Rock Falls Schools. The training was presented in a way that allowed the participants to ask questions and interact in scenarios. Teachers were offered the opportunity to stay after the presentation and have the trainer examine their classrooms. This allowed the trainer and teachers to create a safety plan that is specific to each teacher and their classroom location.

Detectives also evaluated the building layout for several of the local businesses. Two of these businesses wished to have a detective speak to their employees in an active shooter type presentation. Much like the ALICE training, the presentation allowed workers and employers to openly ask questions throughout the presentation. In many occasions, the owner/owners of the businesses wanted detectives to stay after the presentation in order to discuss ways to make their business a safer environment.

An elderly scam presentation was offered and presented to the residents of Rock Falls. Detectives coordinated with a local bank employee and the Deputy Chief of the Rock Falls Fire Department. The presentation covered phone scams, internet scams, bank account theft, and fire safety for the elderly. Many of the attendees had multiple questions about specific scams that they were victims of.

One of the local banks reached out and requested a detective speak to their employees in reference to what they should do in the event of a bank robbery. A detective spoke with the employees in an open discussion type lecture.

#### Alcohol compliance checks

Detectives performed a citywide alcohol compliance check on February 8, 2023. Seven businesses were randomly selected. This compliance check resulted in five out of the seven businesses receiving city ordinance tickets for non-compliance.

Detectives performed a citywide alcohol compliance check on June 13, 2023. Eight businesses were randomly selected. This compliance check resulted in one out of the eight businesses receiving city ordinance tickets for non-compliance.

Detectives produced educational materials for all the liquor license holders in order to help them maintain compliance.

Detectives are also tasked with other routine operations within the Department.

#### 1. Vault maintenance

- a. Processing and entering all items from cases.
- b. Regular court record and status checks through State's Attorney's Office. This allows detectives to determine whether an item needs to be preserved further or if the item is no longer required and can be disposed of.

#### 2. Evidence to crime lab

- a. Detectives need to make regular trips to the Rockford crime lab in order to maintain the investigations of cases.
- b. Detectives are also tasked with keeping up with the lab results and making sure lab reports/results are placed in the proper files and also supplied to the Officers for determining arrests and completing their reports.

#### 3. Impound vehicle disposal

- a. Certified letters need to be completed and sent. Detectives will investigate and determine whether the vehicle is owned outright or if the vehicle also has a lienholder. Letters need to be completed and sent to both owner and lienholder.
- b. Unclaimed vehicles need to be sold to a certified parts dealer for destruction. A certificate of purchase letter is to be completed. The outcome of the vehicle then needs to be properly documented.

#### 4. Alcohol and tobacco compliance checks

- a. Quarterly alcohol and tobacco compliance checks are completed by detectives.
- b. A confidential source needs to be acquired. Source needs to meet certain physical and age requirements.
- c. The checks are completed and a report is required.

- 5. Crimestoppers
  - a. Regular Crimestoppers meeting are attended by detectives.
  - b. Detectives stay updated on Crimestoppers website and are responsible for sharing information with other agencies when required.
- 6. Pawnshop reports
  - a. Detectives are to maintain communication with local and surrounding pawn shops.
  - b. Detectives are responsible for making sure pawn shop reports are obtained and documented properly.
- 7. April House/Child Advocacy Center
  - a. Besides the many April House interviews that detectives attend for cases, detectives also attend regular April House meetings to discuss the statuses of cases and share information with other agencies detectives.
- 8. Monthly detective meetings
  - a. Detectives attend regular monthly detective meetings.
  - b. These meetings are vital and allow detectives, from all surrounding locations, the opportunity to share information and compare cases for possible matching suspects.

#### **Outlook:**

Many changes in law enforcement have occurred in 2023.

Evidence processing now requires a more timely and thorough process for certain items.

In a constantly changing police environment, the Detective Section maintains updated contact with larger departments, Illinois State Police, and other means to stay updated and on top of the latest technology that is available to us.

In 2023, the Detective Section obtained a heat-sealing station for evidence. This has allowed Detectives/Officers the ability to package and seal potentially dangerous or life-threatening evidence, such as illegal drugs, in a manner that increases the safety of RFPD members and crime lab members.

#### The Detective Division goals for 2024:

- 1. Continuing to stay in touch with community members through educational seminars.
- 2. Increase drug-related investigations when possible.
- 3. Maintain/increase knowledge of all new investigation tools available to us.
- 4. Continue to work side by side with surrounding agencies.




