SCOPE OF WORK:

The City of Rock Falls Street Department is requesting bids for Sidewalk, and Curb and Gutter replacement and improvement. Work to be completed will be various linear feet of curb and gutter, and various square feet of sidewalk. This contract will begin June 1st, 2019 and continue through May 31st, 2020. A list of projects will be supplied to the contractor.

The City retains the right and option to extend the contract for 1 to 2 additional years, ending on either May 31st, 2021 or May 31st, 2022. If the contract is extended, the contractor shall complete the additional projects assigned at the same Unit Prices as originally quoted below.

All work shall be in accordance with the Illinois Department of Transportation's Standard Specification for Road and Bridge Construction, dated April 1, 2016, this Proposal or as directed by the City.

Unit Price bid per Square Foot for Sidewalk-5" shall include Earth Excavation, Aggregate Base Course (Type B), and Portland Cement Concrete Sidewalk, 5".

Detectable Warnings will be paid for separately at the Unit Price bid per Square Foot for Detectable Warnings.

Unit Price bid per Foot for Curb and Gutter shall include Earth Excavation, Aggregate Base Course (Type B), and Combination Concrete Curb & Gutter.

Award for Contract shall be based on the Unit Price bid per Square Foot for Sidewalk – 5".

CONDITIONS

All work performed under this contract shall be subject to compliance with the Illinois Prevailing Wage Act. Contractors are required to submit certified copies of their payroll, and shall sign an addendum to verify their understanding of this requirement.

All contractors submitting quotes must be registered contractors with the City of Rock Falls.

The contractor shall furnish to the City an irrevocable **Performance Bond** in the amount of sixty thousand dollars (\$60,000) from a reputable insurance or bonding company acceptable to the City to guarantee the faithful performance of the contract. It shall remain in effect for the full term of the contract, including the extension period of 1 to 2 years, and be delivered to the City with ten (10) days of the awarding of the contract. The contract shall not be signed until the bond is received and is reviewed for acceptability by the City. The bond shall be conditioned on the satisfactory performance by the contractor of all obligations and duties under the contract and shall provide security to the city for any damages or loss suffered by the city because of, or as a result of, any breach or failure to perform by the contractor.

The City of Rock Falls will make payment within (30) days after acceptance of the work billed.

The City of Rock Falls reserves the right to reject any or all quotes.

INSURANCE

All quotes shall be accompanied by a certification of the bidder certifying that the bidder can provide a certificate of insurance. In addition, the successful bidder must name the City of Rock Falls as an additional insured on the required certificate of insurance.

SPECIFICATIONS:

CURB & GUTTER

This item shall be in accordance with Section 606 of the Standard Specifications, this Proposal and the Standards attached to this Proposal, or as directed by the City in the field. 4" of Aggregate Base Course, Type B (CA-6), shall be placed under the curb and gutter prior to installation.

Locations for removal and replacement of the existing curb and gutter will be determined and marked by the City. As noted elsewhere in these Special Provisions, the contractor shall saw-cut existing curb and gutter prior to removal. Cost of saw-cutting is incidental to contract. Unless otherwise allowed by the City, the contractor will be required to install a construction joint with dowel bars at all locations where the new curb and gutter connects to existing curb and gutter. When feasible, the new curb and gutter section shall match the existing section, otherwise, the contractor will be required to install curb and gutter conforming to either Combination Concrete Curb and Gutter, Type B-6.18, or Type B-6.24, unless an alternate section is approved by the City.

Expansion joints shall be installed a maximum of 5' away from inlets and other structures. If a length of replacement curb and gutter exceeds 15' in length, the contractor shall saw joints in the new curb and gutter at maximum intervals of 15' no later than one day after the concrete has been poured. All joints, whether between new and existing curb and gutter, or sawed joints in new curb and gutter, shall be sealed in accordance with Section 606.07 of the Standard Specifications within 1 day of being installed.

Where necessary, new curb and gutter shall be depressed as required for driveways and intersecting sidewalks.

Payment will be made at the contract unit price bid per FOOT for CURB & GUTTER and shall include materials, labor, equipment and Earth Excavation and Aggregate Base Course, Type B, as noted elsewhere within these Specifications.

SIDEWALK, 5"

DETECTABLE WARNINGS

These items shall be in accordance with Section 424 of the Standard Specifications, this Proposal or the Standards attached to this Proposal and as directed by the City. 4" of Aggregate Base Course, Type B (CA-6), shall be placed under the sidewalk prior to installation.

The Contractor shall install handicap ramps at locations selected by the City. Curbs on ramps will not be paid for separately.

Detectable warnings, in compliance with the Illinois Accessibility Code and ADA standards shall be installed where directed by City. Material for Detectable Warnings shall be cast iron, as required and approved by the City. Plastic Detectable Warnings will not be allowed. Color to be approved by the City.

Payment will be made at the contract unit price bid per SQUARE FOOT for SIDEWALK – 5” or per SQUARE FOOT for DETECTABLE WARNINGS and shall include materials, labor, equipment and Earth Excavation and Aggregate Base Course, Type B, as noted elsewhere within these Specifications.

EARTH EXCAVATION

Earth Excavation shall be in accordance with Section 202 of the Standard Specifications, this Proposal, or as directed by the City.

This item shall include, but not be limited to, the removal and satisfactory disposal of all existing concrete curbs, gutters, and sidewalks (where marked or as directed by the City), that area of bituminous pavement necessary to install proposed Curb and Gutter, or any earth excavation required to install the Aggregate Base Course (Type B) below either the Sidewalk or Curb and Gutter.

Depth and width of Earth Excavation shall be that required to install 4” of Aggregate Base Course and Portland Cement Concrete Sidewalk, 5”, or 4” of Aggregate Base Course and Combination Concrete Curb and Gutter, Type B-6.24.

During removal operations, special care shall be taken to prevent damage to adjacent items remaining in place. In particular, at all locations where existing curb and gutter to remain in place is adjacent to curb and gutter to be removed, the existing curb and gutter shall be saw-cut by the Contractor prior to removal. The cost of any saw cutting required prior to removal is incidental and shall be included in the Unit Price bid for either Curb and Gutter or Sidewalk.

Earth Excavation shall include all materials encountered except rock, and no other classification of excavated materials will be made. . Payment for Earth Excavation will not be made separately but shall be incidental to the contract Unit Price per Foot for Curb and Gutter or Sidewalk.

AGGREGATE BASE COURSE, TYPE B

This item shall be in accordance with Section 351 of the Standard Specifications, this Proposal, or as directed by the City. Material used shall meet the requirements of IDOT CA-6.

The contractor shall backfill immediately after excavation, placing and mechanically compacting a minimum of 4” of Aggregate Base Course prior to installation of the proposed curb and gutter or sidewalk.

Payment for Earth Excavation will not be made separately but shall be incidental to the contract Unit Price per Foot for Curb and Gutter or Sidewalk.

PREVAILING WAGE CERTIFICATION

Contractor agrees that not less than the prevailing rate of wages, as found by the Department of Labor of the State of Illinois, shall be paid to all laborers, workers and mechanics performing work under the contract, and Contractor agrees that all subcontracts and lower tiered subcontracts shall contain a written stipulation that not less than the prevailing rate of wages shall be paid to all laborers, workers and mechanics performing work under such subcontract or lower tiered subcontract, all as determined by the Department of Labor of the State of Illinois.

Contractor also agrees that it shall:

1. Make and keep for a period of not less than three (3) years, records of all laborers, mechanics and other workers employed on the project, including each worker's name, address, telephone number when available, social security number, classification or classifications, hourly wages paid in each pay period, number of hours worked each day, and the starting and ending times of work each day; and
2. Submit no later than the 15th day of each calendar month a certified payroll for the immediately preceding month with the City Clerk until such time the Illinois Department of Labor activates their database at which time certified payrolls shall be only submitted to that database.

At the time of request for each progress payment, Contractor shall deliver to Owner a contractor's affidavit listing all suppliers of labor and material, the work performed by each, the amounts paid to each to date, the amount due for work performed to date and a waiver of lien for any payments made to any such supplier signed by such supplier.
