REGULAR MEETING OF THE MAYOR AND ALDERMEN OF THE CITY OF ROCK FALLS September 21, 2010

The regular meeting of the Mayor and Aldermen of the City of Rock Falls was called to order at the hour of 6:30 p.m., September 21, 2010 in Rock Falls, Illinois by Mayor David Blanton.

Deputy City Clerk, Michelle Conklin, called the roll, present were Mayor Blanton, Alderman Vandersnick, Reitzel, Kuhlemier, Schuneman, Hand, Folsom and Thurm. Alderman Snow being absent.

Julie Jacobs, Executive Secretary from Blackhawk Hills Resource Conservation and Development awarded the City of Rock Falls with approximately \$115,000.00 in Energy Efficiency and Conservation Block Grants. The grant award will be used for City Hall lighting upgrades, Community Building lighting upgrades and window replacement, Electric Department lighting upgrades and a solar panel for the Electric Department.

A motion was made by Alderman Kuhlemier and second by Alderman Vandersnick to accept the Energy Efficiency and Conservation Block Grants from Blackhawk Hills Resource Conservation and Development. Upon roll call Alderman Vandersnick, Reitzel, Kuhlemier, Schuneman, Hand, Folsom and Thurm voted aye. Vote: 7 aye. Motion carried.

Mr. Marty Kapp addressed the City Council with concerns that he has with the ordinance regarding storage containers. After discussion, Mr. Kapp was advised to contact Building Inspector Mark Searing to answer any questions that he may have.

Brody Henson, Boy Scout Troop 902, Drew Henson and Collin Jakubczak, Cub Scout Pack 323 addressed the City Council and informed them that the Boy Scouts and Cub Scouts are continuing their collection of food for the food pantry's in town. On Saturday, October 9, 2010 they will be going door to door in the City of Rock Falls to distribute bags and door knockers and on October 16, 2010 they will be going door to door to collect any donations of food.

A motion was made by Alderman Thurm and second by Alderman Reitzel to approve the Boy Scouts and Cub Scouts going door to door to collect food to stock the food pantry's. Mark Searing, Building Inspector presented the City Council with a plaque from the U.S. Census Bureau thanking the City for their participation in the 2010 Census. Mark Searing stated that the Complete Count Committee had been disbanded but he would like to thank everyone on the committee for their hard work.

A motion was made by Alderman Hand and second by Alderman Folsom to approve the closure of East 3rd Street from 1st Avenue to Avenue A on Saturday September 25, 2010 from 8:00 a.m. until 12:00 p.m. for the annual NICIL Walk and Roll.
