REGULAR MEETING OF THE MAYOR AND ALDERMAN OF THE CITY OF ROCK FALLS

November 2, 2010

The regular meeting of the Mayor and Alderman of the City of Rock falls was called to order at the hour of 6:30 p.m., November 2, 2010 in Rock Falls, Illinois by Mayor Pro Tem Glen Kuhlemier.

City Clerk, William B. Wescott, called the roll following the pledge of allegiance, present were Mayor Pro Tem Kuhlemier, Alderman Vandersnick, Reitzel, Snow, Schuneman, Hand, Folsom and Thurm. In addition, City Administrator Richard Downey and City Attorney Jim Reese were present.

Employee recognition:

City Administrator Downey introduced our (2) two newest employees to the Council. Jenna Kuster (05/03/10) and Stephanie Johnson (10/11/10) both are employed in the positions of Utility Clerks in the City's Customer Service Center. Both ladies thanked the Council for the opportunity that has been extended to them with the positions.

Community Affairs:

Sand Henriken, Executive Director, Rock Falls Community Development Corporation announced to the Council that on October 29, 2010 Governor Quinn announced nearly \$90 million for Transportation Enhancement Projects in Illinois as part of the Illinois Transportation Enhancement Program (ITEP). Rock Falls received a \$240,000 grant for the Engineering study of the Riverside Bike & Walk Trailhead Corridor. The Grant 80-20, which will obligate the City through whatever sources, to contribute \$60,000 to the project by the year 2015, bring the total grant to \$300,000.
