### REGULAR MEETING OF THE MAYOR AND ALDERMAN OF THE CITY OF ROCK FALLS December 7, 2010

The regular meeting of the Mayor and Alderman of the City of Rock falls was called to order at the hour of 6:30 p.m., December 7, 2010 in Rock Falls, Illinois by Mayor Pro Tem Glen Kuhlemier.

City Clerk, William B. Wescott, called the roll following the pledge of allegiance, present were Mayor Pro Tem Kuhlemier, Alderman Vandersnick, Reitzel, Snow, Schuneman, Hand, and Folsom. Alderman Thurm was absent. In addition, City Administrator Richard Downey and City Attorney Jim Reese were present.

### **Employee Recognition:**

Chief Mike Kuelper addressed the Council and presented information about the Illinois Department of Transportation's Division of Traffic Safety (IDOT/DTS) "DUI Enforcement Award" program. The program is designed to recognize Police Officers who excel in arresting impaired drivers, making the roads a safer place by aggressively enforcing DUI laws. Awards are presented to any officer who has made at least 25 DUI Awards since the programs inception in 2001. As arrest accumulates officers are recognized at different levels of accomplishment. Chief Kuelper presented three (3) of our Officers for public recognition in regards to there accomplishments in this program; Sgt. John Worcester (27) arrest, Sr. Patrolman Dave Pilgrim (29) arrest and Sr. Patrolman Jim Holloway (201) arrests. Each officer was presented a certificate from (IDOT/DTS) and received a recognition pin which recognizes there accomplishment. Chief Kuelper and the entire Council applauded the work done by these officers and the entire Police force in keeping our roads and community safe.

#### **Community Affairs:**

Doug Wiersema, President/CEO, Rock Falls Chamber of Commerce presented a report on the recent Hometown Holidays activities. It is estimated that between 4500-5000 residents and visitors were in the downtown area during Friday night's celebration. The event continues to grow with several new activities being added to the program calendar this year. While it takes a large coordinated effort to have this weekend be a success, Mr. Wiersema wanted to publicly thank Bethany Bland who pulls this entire event together year end and year out. The City Street Department, Electric Department and Police Department go above and beyond in there support and actions, Boy Scout troop 323 placed out over 500 luminaries which added to the old town appeal to the many events. The event was truly a success and once again demonstrates the community spirit that exists here in Rock Falls.
