# REGULAR MEETING OF THE MAYOR AND ALDERMAN OF THE CITY OF ROCK FALLS

May 17, 2011

The regular meeting of the Mayor and Alderman of the City of Rock Falls was called to order at 6:30 p.m., May 17, 2011 in Rock Falls, Illinois by Mayor David H. Blanton.

City Clerk, William Wescott, called the roll following the pledge of allegiance, present was Mayor Blanton, Ald. Vandersnick, Reitzel, Snow, Kuhlemier, Schuneman, Hand, Folsom and Thurm. In addition, City Administrator Richard Downey and Attorney Jim Reese were present.

He told the council that 56 students were recognized with \$791,619.32 awarded in scholarships.

- 2. Reported that the 1<sup>st</sup> City Newsletter is completed and will be going out in the utility bills soon.

#### Water/Street- Mr. Padilla

Donna had worked for the City ofr 20 years and was well known and a highly respected individual amongst Police, Fire and EMS. In honor of Donna, Chief Kuelper request the City allow for the planting of a lilac bush here on City property has a memorial to Donna's service and memory.

## Ward Reports:

Ward 2 – Alderman Kuhlemier reported that as a setting member of the Rock Falls Convention and Tourism Board he wanted the Council to be aware, that the Board is currently working on its award procedures policy.

# Mayor's Request:

1. Mayor as the City's Liquor Commissioner Request the Council approve a Special Liquor License be issued to the Rock Falls Chamber of Commerce for June 8-9, 2011. They have met all of the requirements necessary for such issuance.

Motion: Ald. Hand-Second: Ald. Reitzel to approve the special liquor license as requested. Vote: 8 ayes, motion carried

- 2. Mayor request that the Council approve Willet Hoffman & Associates let bids for the following road projects: East Second Street from First Avenue (Illinois Route 40) to Wood Avenue; Avenue A from East Second Street to East Third Street. Bids for these projects are to be let as two separate projects. Motion: Ald. Vandersnick-Second: Ald. Kuhlemier to approve the mayors request for the letting of the bids for the above identified street projects. A discussion ensued, in which Ald. Snow questioned what would be the funding source for either of these projects. Mayor Blanton responded the ½ cent sales tax. Ald. Snow expressed his concern over going forward with this project, when the Public Works committee has already made decisions concerning other projects that they have identified spending the ½ cent sales tax for. Ald. Schuneman addressed the same concerns, adding that we need to move forward with the projects that have been identified by Public works. Other Alderman engaged in the discussion sending the issue back and forth, Ald. Reitzel, Chairman Public Works stated that to his understanding, the Mayor's original motion calls only for the letting of the bids as separate projects. The motion does not include the funding source. So at this time we should let the bids and see what type of pricing we get back and then we can conduct further discussions concerning the funding source for the project. The mayor concurred, by stating that no monies for either project can be allocated without Council approval. City Clerk Wescott re-stated the motion and the roll was read: Vote 8 ayes, motion carried.
- 3. Mayor Blanton requested that a temporary City Administrator be named to fill the position once Mr. Downey leaves. Ald. Hand made a motion to name Mayor Blanton as interim City Administrator once Mr. Downey vacates the position. Seconded: Ald. Kuhlemier. Vote: 8 ayes, motion carried.

Mayor Blanton requests a motion to enter into executive session for:
