### Community Affairs:

- 3. City of Rock Falls received word from the Office of the Governor that they will be receiving an additional \$41,603.00 in MFT funds this year via the 2009 Illinois Jobs Now initiative which is scheduled to run over five (5) years.
- 4. Faith Baptist Church 2005 Freeport Road, Sterling will be holding a recognition service for the area law enforcement personnel and their families on October 21, 2012.
- 5. Street Department and the City received a "thank you" from the members of the First Methodist Church for repairs that were made to their sidewalk in a timely fashion
