The regular meeting of the Mayor and Alderman of the City of Rock Falls was called to order at 6:30 p.m. on October 2, 2012 in Rock Falls, Illinois by Mayor David Blanton, City Clerk, William Wescott, called the roll following the pledge of allegiance, present was Ald. Community Affairs:

Darla Schryver, member of the Executive Board of the Chamber of Commerce was present to present information on upcoming events. The recent Garage sales days were highly successful as a record 128 different locations participated; October 19th the Chamber is sponsoring a "Meet the Candidates" Night with a Celebrity bartender event at Long Shots from 5:30 – 7:30 p.m.; November 15-18, 2012 will be the Hometown Holidays celebration, with the parade to be held on Saturday, November 17th.
