REGULAR MEETING OF THE MAYOR AND ALDERMAN OF THE CITY OF ROCK FALLS April 19, 2005

The regular meeting of the Mayor and Alderman of the City of Rock Falls was called to order at the hour of 6:30 p.m., April 19, 2005 in Rock Falls, Illinois by Mayor Edward M. Mulvaney.

City Clerk William Wescott, called the roll, present were mayor Mulvaney, Alderman Stachowiak, Searing, Kuhlemier, Straub, Charnas, Hand, Folsom and Blanton.

Audience Requests:

Mr. Mike Spain, representing the local Postal Carriers informed the Council of the upcoming Letter Carriers Food Drive that is to be held on Saturday, May 14, 2005. The Postal Service food drive is the largest held annually throughout the United States. All food that is collected stays in the local communities and is distributed to area food banks and pantries. Last year in the Sterling-Rock Falls area alone, 30,600 lbs. (15.3 Tons) of non-perishable food items were collected. It marked the 6th consecutive year that 15+ Tons of food was collected. Mr. Spain thanked the members of the local area for there support of this project and encouraged everyone to participate again this year; by placing non-perishable food items in a bag by there mailboxes on May 14th and the Postal Service employees will do the rest. Anyone who would like to volunteer to assist on that day should contact the local Post Office.

Correspondence/Resolutions:

Clerk Wescott read a letter that was received from the Blackhawk Hills Economic Development District. They are asking for a contribution of \$75.00 to help offset the costs associated with a legislative roundtable meeting and reception with our federal legislators on the afternoon/evening of May 10th. The intent of the meetings in Washington, D.C. are to strongly encourage our legislators to reauthorize and fully fund USDA and Department of Commerce programs that directly affect our organizations and region. **A motion** by Alderman Blanton and seconded by Alderman Stachowiak to approve the expenditure as requested. Electric Department- Mr. Jakubczak also welcomed the new Council members. He spoke briefly about the Broadband Project and will hope to have more information available at the next meeting.

Fire Chief- Mr. Larson welcomed the new Council members and wished them the best.

Street Department- Mr. White welcomed the new council members and reported that he has the street sweeper out doing the main roads at this time

Wastewater Treatment- Mr. Cox advised that the catch basins have been identified and repairs will begin soon. The project at Rock River Christian Center to join the line with Anixter is on temporary hold till the ground dries out. But that project should be completed this spring. The digester repairs are complete and a savings of \$2500 was achieved on the project.
