	 e. River Trail Status Boat Access – Mayor Wescott presented the committee with information and pictures of 2 different canoe docks recommended from the Park District in Lena. He has also spoken with them about ADA access and will meet with him in the future. 	No action
	f. Riverfront Trail – Mayor Wescott reported, that a rough	

	access road has been added to the riverfront along with adding a base for the bike trail along the river. He stated that Brian Tribley with the Firehouse of God church is looking forward to another project along the riverfront. They would like to now help clean up the brush along the water on East 2 nd St. The Mayor informed the committee that Wendler Engineering who has done Phase One for the riverfront planning will be at the next Committee of the Whole Meeting on August 26 th . The engineers did not allow enough clearance under the 1 st Avenue Bridge for a walking or bike path under the bridge to connect Bowman Park to the rest of the riverfront as was planned for years by the city.	
	g. Canal Dredging Project - Mayor Wescott reported that the City Council approved Willett Hoffman & Associates to start the engineering to begin the permitting process from the US Army Corps of Engineers for dredging. He also reported that there is currently a problem with a bladder on the dam, and it is being worked on. The mayor did mention to Randy from the corps that if they needed to drain Lake Sinnissippi again to make repairs it would be a good time to more easily dredge.
