

Reconvened Meeting of the  
Municipal Officers Electoral Board of the City of Rock Falls

January 16, 2013

Glen Kuhlemier called the meeting of the Municipal Officers Electoral Board of the City of Rock Falls to order at 3:00 p.m. Upon roll call Glen Kuhlemier, Lee Folsom and Pamela Erby answered present.

After reviewing the minutes of the meeting of the Municipal Officers Electoral Board of the City of Rock Falls of January 11, 2013 there is a correction that needs to be made. Lee Folsom is the longest serving board member and Glen Kuhlemier is the second longest serving board member. Erby made a motion to that the corrections be made to the meeting minutes of January 11, 2013, Folsom seconded. Upon roll call Kuhlemier, Folsom and Erby voted aye. Vote: 3 ayes; 0 nays. Motion carried.

Allen Boseneiler at this time wished to present a motion to the Electoral Board, Chairman Kuhlemier stated that this was a meeting only to present and approve the written findings as required by law and no further comments were to be received or accepted.

The first case to be discussed is 2013-1 Searing vs. Boseneiler. Pamela Erby read the findings and order of the Municipal Officers Electoral Board of the City of Rock Falls. Based on the findings and conclusions drawn from the evidence, the Municipal Officers Electoral Board orders that the name of Allen F. Boseneiler, also referred to as Allen Boseneiler, and also referred to as Allen F. (Cassens) Boseneiler be removed from the ballot and that his nomination petitions be stricken for the reason that Allen F. Boseneiler is ineligible to run for the Office of Mayor of the City of Rock Falls at the April 9, 2013 election for such office. Folsom made a motion to approve the findings and order that the name of Allen F. Boseneiler be removed from the ballot and that his nomination petitions be stricken for the reasons set forth in the written findings and order, Erby seconded. Upon roll call Kuhlemier, Folsom and Erby voted aye. Vote: 3 ayes; 0 nays. Motion carried.

A copy of the order was presented to Mark Searing, Objector and Allen F. Boseneiler, Respondent-Candidate by Police Chief Michael Kuelper.

The second case to be discussed is 2013-2 Boseneiler vs. Blanton. Pamela Erby read the findings and order of the Municipal Officers Electoral Board of the City of Rock Falls. The Board finds that the Objector's purported Objection is not an Objection at all, but merely a request for the Board to perform functions which it

is not legally authorized to perform, and for that reason, the motion of Candidate Blanton to dismiss and strike the Objection is granted. Erby made the motion to approve the written findings and order to dismiss and strike the Objection, Folsom seconded. Upon roll call Kuhlemier, Folsom and Erby voted aye. Vote: 3 ayes; 0 nays. Motion carried.

A copy of the order was presented to David Blanton, Respondent-Candidate by Police Chief Michael Kuelper, Allen Boseneiler, Objector was not present. A copy of the Order will be sent to him by Mail by Attorney James Reese.

The third case discussed is 2013-3 Boseneiler vs. Wescott. Pamela Erby read the findings and order of the Muncipal Officers Electoral Board of the City of Rock Falls. The Board finds that the Objector's purported Objection is not an Objection at all, but merely a request for the Board to perform functions which it is not legally authorized to perform, and for that reason, the motion of Candidate Wescott to dismiss and strike the Objection is granted. Folsom made the motion to approve the written findings and order to dismiss and strike the Objection, Erby seconded. Upon roll call Kuhlemier, Folsom and Erby voted aye. Vote: 3 ayes; 0 nays. Motion carried.

A copy of the order was presented to William Wescott, Respondent-Candidate by Police Chief Michael Kuelper, Allen Boseneiler, Objector was not present. A copy of the Order will be sent to him by Mail by Attorney James Reese.
