# REGULAR MEETING MINUTES OF THE MAYOR AND ALDERMEN OF THE CITY OF ROCK FALLS

# December 16th, 2014

The regular meeting of the Mayor and City Council of Rock Falls, Illinois was called to order at 6:30 p.m. December 16th, 2014 in the Council Chambers of Rock Falls by Mayor William B. Wescott.

City Clerk Eric Arduini called the roll following the pledge of allegiance. A quorum was present including Mayor William B. Wescott, Aldermen Reitzel, Logan, Kuhlemier, Snow, Schuneman, Hand, Folsom, and Watts. In addition City Attorney Jim Reese, and City Administrator Robbin Blackert were present.

#### **Audience Request:**

Rod Klecker of 219 Avenue C took a minute to explain that it would be helpful if the City would update their website with agendas, and minutes sooner. He also asked what is happening to the bike path with the hotel now being built on the riverfront.

Mayor Wescott explained that the city is working on building a new website that will help the city get more information to the public sooner. He also explained that the Bike and Walk Path will be along the park and extend under the First Avenue Bridge.

City Administrator Robbin Blackert explained that the path will continue behind the hotel and go east from the park.

## Gifting of Real Estate to the City - Doris M Celletti Revocable Trust

Mayor Wescott introduced Dennis Celletti to the Council. Mr. Celletti's parents Louis and Doris Celletti are gifting a parcel of land to the City. This land is just east of the new hotel. Mayor Wescott explained that there will be a path across the land, and within three years the City is to develop a picnic area, or overlook recognizing the Celletti Family. Alderman Kuhlemier agrees with giving recognition to Mr. and Mrs. Celletti Dennis Celletti considers it an honor to contribute to the city, and remember his parents. A motion to approve resolution 2014-702 approving the gift of real estate and conditions for acceptance was made by Alderman Kuhlemier, and second by Alderman Folsom. Vote 8 Aye, motion carried

#### Ordinance 2nd Reading / Adoption

A motion was made by Alderman Hand and second by Alderman Snow to adopt Ordinance 2014-2187 Tax abatement for electric bond.

A motion was made by Alderman Snow and second by Alderman Logan to adopt Ordinance 2014-2188 Tax abatement for motor fuel tax bond.

Alderman Kuhlemier explained that the tax abatement bond ordinance contains language that if the tax abatements do not take place, they would end up costing the taxpayers money in taxes.

A motion was made by Alderman Snow and second by Alderman Shuneman to adopt Ordinance 2014-2191 Directing the advertisement for bids to sell surplus real estate (606 East 4th Street)

Mayor Wescott asked what the amount for MFT would be and Adm. Blackert stated \$152,000. She explained that MFT totals need to be given ahead of time, and they run calendar year. The city has been able to acquire salt at \$77.77 per ton which is higher than last year, but lower than many other communities that are going to be paying \$100.00 per ton. Adm. Blackert also explained that emulsion and rock for the emulsion machine has been added to this amount this year.
