The City does not have enough resources to monitor for compliance all over town, and it is difficult to figure out where the smoke comes from. Alderman Snow states that people abuse the current ordinance. It leads to health issues, and wet leaves are left to smolder. Alderman Reitzel had reports of people burning leaves in the street. He mentioned that recreational fires are allowed in Sterling, but if a neighbor complains, it needs to be put out. Alderman Schuneman asked that more time be taken to consider this issue. It is hypocritical that the City burns prairies in town, and would not let residents do the same. There was much discussion on the contract with the waste hauler.
