REGULAR MEETING MINUTES OF THE MAYOR AND ALDERMEN OF THE CITY OF ROCK FALLS

August 1st, 2017

The regular meeting of the Mayor and City Council of Rock Falls, Illinois was called to order at 6:30 p.m. on August 1st, 2017 in the Council Chambers of Rock Falls. A motion was made by Alderman Logan, and second by Alderman Reitzel to name Alderman Glen Kuhlemier as the acting chairperson of the meeting in the absence of Mayor Wescott.

City Clerk Eric Arduini called the roll following the pledge of allegiance. A quorum was present including Aldermen Reitzel, Logan, Snow, Kuhlemier, Schuneman, Kleckler and Sobottka. Aldermen Folsom was absent. In addition Attorney Tom Sanders and City Administrator Robbin Blackert were present.

Consent Agenda:

The consent agenda was read aloud by Clerk Arduini. A motion to approve the consent agenda as presented by omnibus designation was made by Alderman Snow and second by Alderman Sobottka.

Ordinance First Reading

A motion was made by Alderman Schuneman, and second by Alderman Sobottka for the approval of **Ordinance 2017-2330** Addition of Article 11.5 to Chapter 16 – Food Truck Vendor License.

City Administrator Robbin D. Blackert:

A motion was made by Alderman Logan, and second by Alderman Schuneman for the approval of the Code Enforcement job description.

Administrator Blackert informed the Council that the contractor for the Limestone Building has been moving ahead and doing a good job even though the funding did not come from the IEPA in a timely manner. The crews removed 13 semi loads today, and the air quality tests were extremely good. They did have one issue when a corner of the building fell onto the fence.

After the RB&W Park dedication, EPA and IEPA personnel visited the former Parrish Alford site. They are interested in helping the City finish the assessment and cleanup of the site by reopening the NFR, and finding additional funds to help remediate the area.

The USEPA took video from the park dedication, and sent word of the 11 year progress from a judicial deed to redevelopment to Washington DC as a poster child of what the brownfield program can do. Adm. Blackert thanked everyone for their help with the park dedication. Administrator Blackert gave an overview of all of the upcoming sesquicentennial celebration events.

Alderman Kuhlemier recommended everyone visit the displays at the Rock Falls High School.
