| Approval of Minutes | <ul style="list-style-type: none"> Committee reviewed minutes of the November 18, 2021 Ordinance/License/Personnel/Safety Committee. A motion was made by Alderman Snow and second by Alderman Doane, via voice all approved. | Minutes Approved |
| New Business | <ul style="list-style-type: none"> Class B Liquor License – Majority of food sales percentage for Restaurants Alderman Snow spoke to changing the ordinance to cap Class B Liquor License and requiring 60 percent of gross sales to be food sales. Discussion was had by committee members and other elected officials. Motion was made by Alderwoman McKanna and second by Alderman Doane to have a cap put on the Class B License's to 20, non-gaming revenue to be no less than 60 percent per year. Roll Call Vote, 3 aye, 1 recused, Alderman Snow. Class A-1 Liquor Licenses – Increase in Number Limited. Discussion amongst committee members and elected officials. A motion was made by Alderwoman McKanna to not increase the number of Class A-1 Liquor Licenses, a second by Alderman Doane. Roll Call Vote 3 aye, 1 recused, alderman Snow. Alcohol Sales at the RB&W Park for summer 2022 events. Discussion to change the wording in Section 3.d. Any container used to possess or consume alcoholic liquor on city property shall be non-glass.
