2. Minutes	<ul style="list-style-type: none"> Review of the June 3, 2021 Public Works/Public Property minutes as presented. Motion: Wangelin; second: McKanna motion approved. 	Minutes approved
3. Engineer Report	<ul style="list-style-type: none"> Corey Buck, Willett, Hofmann & Associates stated that we are still waiting on the State regarding the Dixon Avenue Project. The final design for the Limestone Building Property is almost complete and we should be able to place out for bid in a couple of weeks. We should be able to start the project in August and should finish up in September. Administrator Blackert stated the we would like the fill to be hydroseeded so that we don't have any erosion. New Business	<ul style="list-style-type: none"> Alderman Wangelin asked if the street department could go through the list that Code Enforcement Officer Chris Heier provided and get the yellow curbs repainted as they are very faded. Larry Spinka stated that they were out painting so they would take care of getting the curbs painted. 	No action on any items
6. Street Department	<ul style="list-style-type: none"> The street department is out mowing, painting and crack filling will begin as soon as the painting is complete. The Street Sweeper has been repaired and is back out sweeping. 	No action on any items
7. City Administrator	<ul style="list-style-type: none"> Administrator Blackert gave the committee an update on the vandalism at Veterans Park. We are going to tear out the retaining walls in front of the band shell and fill in with concrete, Murray & Sons is getting a quote together for the work. We have a quote for \$2,500.00 from Tom Rowzee to make wrought iron screens to cover the openings that go under the stage. We will be installing 2 cameras at a cost of \$1,500.00 each in order to cover the entire park. The ceiling and walls of the band shell will need to be power washed and the walls will need to be painted to cover the graffiti, we will use the more expensive graffiti paint so that we are able to wash anything off that happens in the future. Cost to repair the damage and the upgrades will probably be between \$15,000.00 and \$20,000.00. 	Will use the emergency purchasing policy to get the work done and will bring to the City Council when the work is complete.
