Approve contract for the sale of parcels 1130326002 and 1130326004 to United Metal Buildings, 407 East Avenue, Sterling, IL 61081.	<ul style="list-style-type: none"> Robbin Blackert explained to members that United Metal buildings would like to purchase 9.5 acres of parcels 1130326002 & 1130326004 in the West Industrial Park. United Metal Buildings would like to move their manufacturing, assembly and sales business to Rock Falls. United Metal Buildings would own drainage easements but City will maintain. The parcels are a total of 9 ½ Acres. Sale will have 4% realtor commission. All City Department Heads have been in contact with United Metal Buildings. Discussion was had amongst members. Patty Martinez questioned the realtor commission and Robbin Blackert contacted realtor and was able to lower the commission cost to 3%.
