

Call to Order	<ul style="list-style-type: none"> <li>Meeting was called to order at 5:15 p.m. by Chairman Snow</li> </ul>	
Audience Request	<ul style="list-style-type: none"> <li>Sara Martin discussed the status of the Tiny Homes ordinance changing the 800 sq feet requirement for residential structures down to 400 sq feet. A lengthy discussion was had by the members and Ms. Martin regarding considerations for lot size, subdividing lots, etc. A motion was made by Alderman Snow to forward the ordinance change from 800 sq feet to 400 sq feet to the City Council, second by Member King, all members voted aye, motion carried.</li> </ul>	Forward to City Council

Inspector Searing informed the committee that our code enforcement software MSI would no longer be supported at the end of the year and that Dacra would be honoring the contractual price for the next two years but the price will substantially increase at the expiration of the current contract.</li> <li>B. 211 1<sup>st</sup> Avenue - Committee discussed the possibility of acquiring the property for the purposes of conveying it to an adjacent property owner for demolition. Building Inspector Searing was directed to advise the adjacent property owner that he had until the end of June to give the City a letter of intent.</li> </ul>
