## Planning & Zoning Commission Application for Rezoning of Real Estate Petition Guide for Residents

1. Fill out application for Petition requesting Rezoning of Real Estate and return to Business Office. A fee of \$75.00 is required.

## 2. Guidelines from Ordinance:

- a. The applicant shall cause notice of time and place of Public Hearing by publication in Newspaper not less than 15 days nor more than 30 days before hearing (not counting date of hearing). sample attached
- b. Notice must be given to adjacent property owners within 250' radius of the property by registered or certified mail with return receipt at least 5 days before the public hearing. A listing of adjacent property owners can be obtained from the Tax Assessor's office in Morrison Courthouse (200 E. Knox St, Morrison, IL -(815)772-5132) sample letter attached.
- c. Public Examination 15 days prior to hearing, a copy of the petition, together with the maps or plans or copies thereof shall be on file, for public examination in the building official's office.
- d. A sign which reads "Notice: this property is the subject of a proposed zoning change. Information may be obtained from the building official." The sign shall be posted on the premises not more than 30 nor less than 15 days prior to the scheduled hearing time.
- 3. Submit proof of newspaper publication and mailing receipts to Building Department 5 days before the public hearing.
- 4. Be available to attend City Council meeting designating petition referral to Planning & Zoning Commission.
- 5. Be available to attend Planning & Zoning scheduled Public Hearing of your petition. All paperwork must be completed, turned in and in compliance BEFORE this meeting, otherwise your request could be declined.
