**BID SUBMITTAL:** Bids must be in a sealed envelope marked "Surplus Vehicles 2023". Bids must be submitted on the provided form only, signed by the bidder, and delivered by mail or in person.

**BID OPENING:** Sealed bids will be accepted until 4:00 p.m. on November 29,2023. Bids will be opened and read aloud on November 30,2023 in the Business Office. Bidders are not required to be present at the bid opening.

**BID AWARD :** The bid will be awarded to highest bidder. The City of Rock Falls reserves the **right to reject** any or all bids in total or in part and to waive any informalities and irregularities, as it may deem to be in the City of Rock Falls best interest. In the event of a tie between the highest bids, the bid award will be determined by the date the bid is recieved. If there is still a tie, a resubmission between the highest bidders will be necessary.

**Payment and Removal of Property:** Payment must be in the form of a cashier's check or certified check made payable to the City of Rock Falls. Full payment must be received, and the property removed from the City of Rock Falls premises at the buyer's expense not later than 5 business days after award. Refunds or exchanges are not allowed and will not be considered.

If I do not comply with these requirements, my bid will be rejected.
