1.Call to Order. – Acting Chairman Snow	The meeting was called to order at 5:30pm	Meeting begins at 5:30pm

5.New Business: a.Review of Ordinance 2018-2360 ordinance Governing Interconnective Services to the City of Rock Falls Electric Distribution System.	Electrical Director Dick Simon informed the committee that this Ordinance had been approved by the Utilities Committee, and addresses renewable energy metering with a “Buy all sell all” approach. A new meter will need to be installed. The renewable system will have paperwork documenting the install. The City will sell all of the power needed for the building, and then buy power back from the customer at the IMEA price which is currently 7.1 cents. The IMEA requires the City to have less than 2% of last year’s peak be renewables within the City.	The committee recommends the Ordinance go to City Council for approval.
