5. Street Department	Street Superintendent, Dave Miller informed the committee that M & R Striping is working now, the contract is getting prepared for the chip seal and gave the committee the listing of streets, Porter will be working on sidewalks.	No Action

City Administrator	City Administrator Blackert informed the committee that the asbestos removal from the Micro Building should be complete by the end of the week, bids for the demolition are going to go out on May 23 with a possible start date in June. The RB&W Park bathroom construction is moving along and should be complete in July. There needs to be repairs done to part of the sidewalk and the park and there will be change order presented to the City Council.
