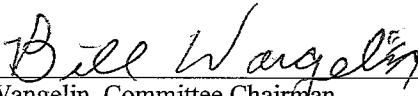

Topic	Discussion	Plan of Action
1. Call to Order	Alderman Wangelin called the meeting to order with a quorum present at 8:15 a.m.	
2. Minutes	Review of the April 7, 2022 Public Works/Public Property minutes as presented. Motion was made by Alderman Wangelin; second by Alderman Dowd. 3 ayes, motion approved.	Minutes approved
3. Engineer Report	- Corey Buck, Willett, Hofmann & Associates informed the Committee that 3rd Avenue is under construction. All of the trees have been removed and NICOR is almost finished with their project. - All of the easements have been completed for the Dixon Avenue Project so we will be ok for a June bid letting.	
4. New Business	- We need to redesignate \$610,000.00 of Motor Fuel Tax Funds to the Dixon Avenue Project, this is the Rebuild Illinois Bond Grant Funds that we have been receiving. Motion was made by Alderman McKanna to approve and send Resolution to City Council to redesignate \$610,000.00 Motor Fuel Tax Rebuild Illinois Bond Grant Funds, second by Alderman Wangelin. Vote 3 aye, motion carried. - Questions have come up again about Stormwater issues on W 19th Street. We had received cost estimates in 2018 for W 19th St, W 20th St and W 21st St for adding curb, gutter and apron and approach for all driveways, we will not core out road but possibly do a grind and overlay. It is possible to do 1 or 2 blocks sections every year, we can look at adding this project to our 5 year plan which will start working on this summer. - Alderman Wangelin wants to look at making Resident Only Parking on W 2nd Street around the high school as there are student parking bumper to bumper and residents can't park in front of their houses. After discussion it was decided that the Resident Only Parking ordinance that we have will be amended to include this area. Motion was made by Alderman Dowd to send amended ordinance to the City Council, second by Alderman McKanna. 3 ayes, motion approved.	Send to City Council No Action Send to City Council

It will be used for yard waste and tree clean up, it will also be available to any of the other departments if they need to use it.
